- We are working on a libguide of resources for assisting non-English speaking or newly arrived library patrons. We may also do a webinar on these resources
- We are working on a webinar and possibly a libguide introducing librarian, especially library students, to minoritized library organizations such as the Chinese American Library Association, The Black Caucus of American Library Association, The National Association to Promote Library & Information Services to Latinos and the Spanish Speaking, American Indian Library Association, Asian Pacific American Library Association, etc.
- We are considering working with DHPSNY to do a workshop on how to help minoritized patrons donate their materials to archives and (possibly) how to make a community archive.

Members of the committee presented at the Fredonia Conference with area Academic Librarians. We were seeking feedback from librarians on the Skills and Areas High School Seniors need when entering College or University.

With that information, we are currently working on updating our Fostering Student Research Skill PD. The committee is developing activities for the following areas:

- e. LEAP: What we've been up to: The LEAP Committee is working on an ArcGIS Asset Mapping Project for library advocacy and education. We will achieve a hand-out district map, providing a visualization for legislators of their library resources. This could elevate their awareness of different library types in their district, the unique services and needs of those libraries, and highlight clusters or gaps in resources. This project also has the potential to be an excellent public tool, doing much the same for community members who also want to know more about specific services. As advocacy season approaches, LEAP members can meet with legislators in the upcoming weeks. We will be pushing for the extension of NOVELny funding. Towards that end, members are speaking with local and state education and library leaders, identifying networking opportunities, and spreading the word so Western New Yorkers and the entire state can keep this critical tool of digital equity.
