  5. Eligible to apply for grants when available
  6. Eligible to utilize member services
- c. **Standard Membership Primary Privileges**
  1. Non-voting
  2. Eligible to serve on the WNYLRC Board of Trustees
  3. Eligible to serve on WNYLRC Standing Committees
  4. Eligible to participate in training and other services at Standard Membership discounted rates
  5. Eligible to apply for grants when available
  6. Eligible to utilize member services
- d. **Patron Membership Primary Privileges (Organizational, Personal, Student)**
  1. Non-voting
  2. Eligible to serve on WNYLRC Standing Committees (one slot is available on each committee)
  3. Eligible to participate in training and other services at Patron Membership discounted rates
